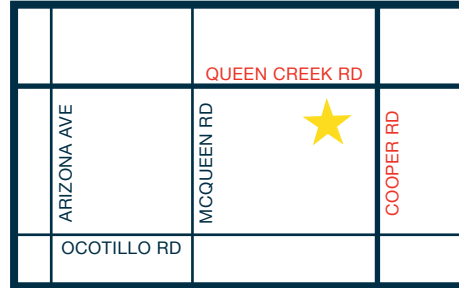

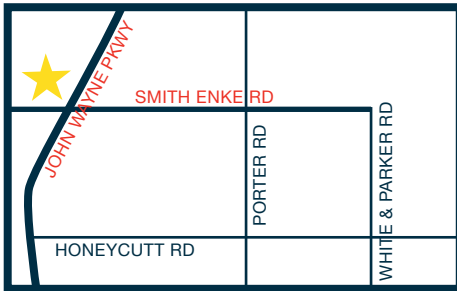
East of Ellsworth Rd, South side of Ocotillo Rd

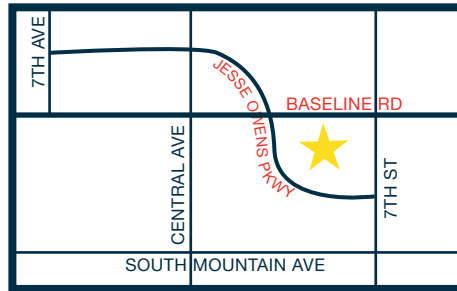
West of Cooper Rd, South side of Queen Creek Rd

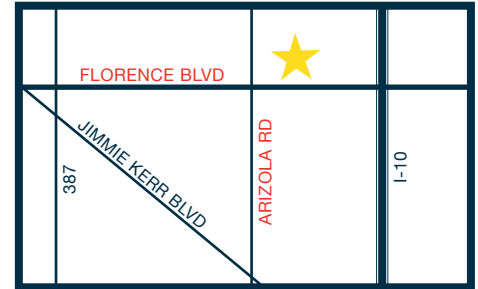
West side of John Wayne Pkwy, North of Smith Enke Rd

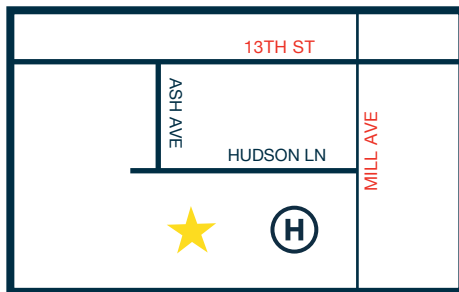

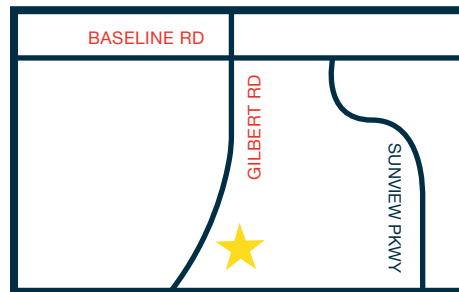
